



## Wyoming Fishing Contest Permit Application

A fishing contest permit is required **if all** of the following three (3) stipulations are met:

1. Event is held on state waters (excluding licensed fishing preserves), **and**
2. Fifty (50) or more anglers participate on a given date, **and**
3. An entry or participation fee is charged

Review the "FISHING CONTEST REQUIREMENTS" document prior to completing this application.

A completed application must be submitted at least **30 days** prior to the start of the contest. Applications will not be accepted more than 1 year in advance of the contest.
