- Large Carnivore Section personnel presented information on the status of wolves in Wyoming at the end of 2013 to the Wyoming Game and Fish Commission. Personnel also presented background on the development of wolf hunting regulations and mortality quotas.

### **Hunting Update**

- Wolves may be hunted in areas when and where they are designated as predatory animals without a wolf hunting license, any time of the year, in any legal manner.

- The Department is in the process of revising Commission Regulation Chapter 47: Gray Wolf Hunting Seasons for the 2014 wolf hunting season. The Department will be collecting public

comments on the proposed revisions from April 15 through 5:00 pm on May 30, 2014. Members of the public are encouraged to attend one of the Public Information Gathering Meetings being held in each of the Department's regions where a presentation covering the proposed revisions will be discussed. Members of the public may also provide comments on the proposed revisions online at the link below. The final proposed regulation will be presented to the Wyoming Game and Fish Commission for consideration and approval during their meeting scheduled July 7-9, 2014 in Dubois, WY.
